Our program services were carried out in West Kalimantan, Indonesia. We provide economic benefits to communities in exchange for adopting new resource management plans centered around large protected areas in Indonesia. Our model utilizes a unique four-step approach to help communities achieve fair and equitable development by building conservation compacts.
